**Agenda No.01/UATEC-16/19**

To report the approval of Minutes of 15<sup>th</sup> Meeting of the UATEC held on 03.10.2018.

**Resolution No.01/UATEC-16/19**

The Member Secretary apprised the members that the Minutes of the 15<sup>th</sup> meeting of the UATEC held on 03.10.2018 was placed before the Academic Council in its 18<sup>th</sup> meeting held on 5<sup>th</sup> February, 2019. The approval of the Academic Council is awaited.

**Agenda No.02/UATEC-16/19**

To apprise about participation of CUSB in Central Universities Common Entrance Test – 2019.

**Resolution No.02/UATEC-16/19**

The Members were apprised about the participation of CUSB in CUCET – 19 for admission in UG/PG and Ph.D. programmes. In this regard the Vice Chancellor had attended the meeting of all the participating Universities held on 17/12/2018 in New Delhi. The Central Universities of Andhra Pradesh and Himanchal Pradesh will also be participating in CUCET 2019.

**Agenda No.03/UATEC-16/19**

To report UGC Letter F.No. 81-1/2019 (CU) date 18.01.2019 regarding Reservation for Economically Weaker Sections (EWEs) for admission in Central Educational Institutions.

**Resolution No.03/UATEC-16/19**

The Secretary apprised the members that the Academic Council in its 18<sup>th</sup> meeting resolved to adopt and implement reservation for EWEs as notified by the GoI.

The members agreed regarding the space crunch being faced by the faculty and students of the University as all the existing programmes are being run in 2 school buildings only. Hence it was resolved not to offer admission under this category for the Academic Session 2019-20 but may be considered from the next Academic Session or thereafter.



#### **Agenda No.04/UATEC-16/19**

To approve the Eligibility criteria of Integrated UG, PG and Ph.D. programmes including the intake of Ph.D. programmes as per the reservation prescribed by Gol.

#### **Resolution No.04/UATEC-16/19**

The approved eligibility criteria, numbers of seats and syllabus for admission in UG PG and Ph.D. (alongwith category wise details) was discussed and the final outline of the same as approved is attached at Annexure – 1. The members also noted that there will be no admissions in M.Tech. (C.S.) from this year.

It was also resolved to request National Coordinator of CUCET to conduct separate examination for Ph.D. Bioinformatics and M.A. Development Studies. Action has been taken and email sent to the National Coordinator for the same. The date of CUCET examination was proposed as 25-26 May, 2019 or 1-2 June, 2019 by the members.

The members also resolved that since the classes of the next Academic Session will commence from July, hence University may conduct One round of admission by fixing reasonable cut - off and preparing a wait list panel of all the students who will not be granted seats in the 1<sup>st</sup> round in each subject. On withdrawal of any admission the University will directly approach the wait listed candidates for taking admission against vacant seats before the date of closure of admissions.

#### **Agenda No.05/UATEC-16/19**

To discuss the Int. B.Sc. B.Ed – 8<sup>th</sup> Semester students application for changing the eligibility criteria for admission in M.Sc. Physics.

#### **Resolution No.05/UATEC-16/19**

The request of the Integrated B.Sc. B.Ed. students for changing eligibility criteria, i.e. B.Sc. with Physics Hons. for admission in M.Sc. Physics (as notified in CUCET – 18) was considered and it was resolved that the admission to M.Sc. Physics will be open to any student having Bachelor's Degree in Physics.

To discuss about the proposal of Department of Bioinformatics regarding separate Question Paper for admission in Ph.D. programme in Bioinformatics.

**Resolution No.06/UATEC-16/19**

To review the existing fee structure for all programme of studies in Academic Year 2019-20.

**Resolution No.07/UATEC-16/19**

The UATEC resolved to continue with the same fee structure as notified in 2018 for Academic Session 2019-20, with no change in the same.

To discuss the evaluation system of Skill – based Courses offered under CBCS.

**Resolution No.08/UATEC-16/19**

The Secretary apprised the members that the examination department has received markings in the Skill Based Courses both in numerical grades as well as with 'Satisfactory / Not Satisfactory' remarks. As per the CBCS Ordinance, all the Skill Based Courses are to be marked as Satisfactory / Not Satisfactory. UATEC resolved that henceforth marking system as notified in the CBCS Ordinance be followed by all concerned Departments.

To start Ph.D. programmes in the new Departments.

**Resolution No.09 (i)/UATEC-16/19**

The members were apprised that in the 18<sup>th</sup> Academic Council it has been decided to start Ph.D. programmes in all new departments i.e. Physics, Chemistry, History & Commerce, if there are permanent faculty available in the department. The UATEC resolved that since the Departments of Physics and Chemistry has 2 (two) permanent Assistant Professors in each, hence the University may notify admission for 8 seats in Ph.D. programme in each of the subject/Department. Since there is no permanent faculty in Department of History and Commerce, the Ph.D. admission in these will be considered in Academic Session 2020-21 after appointment of permanent faculty members.


**Agenda No.09 (ii)/UATEC-16/19**


Reservation of seats for employees of ward in UG/PG programmes as supernumerary quota.

**Resolution No.09 (ii)/UATEC-16/19**

All the members opined that university should implement 5% to 10% reservation in admission in all UG and PG programmes for the wards of employees as supernumerary seats. The matter was discussed at length and the UATEC recommended that the matter may be placed before the Academic Council for decision in its next meeting.
