
The meeting of UATEC members alongwith HoDs/HoDs(I/c) (Non members of UATEC) as special invitee was held on 24.06.2019 in the administrative block under the Chairmanship of Prof. Sankar Kumar Bhaumik, Dean, School of Social Sciences and Policy.

At the outset the Chairperson welcomed all the members of University Admission, Teaching and Evaluation Committee (UATEC) and the special invitees and briefed about the Agenda of the meeting.

After the opening remarks of the Chairperson, the agenda of the meeting was taken up seriatim.

Agenda No.01/UATEC-18/19

To confirm the Minutes of 17th Meeting of the UATEC held on 16.05.2019.





Resolution No. 01/UATEC-18/19

The minutes of the 17th Meeting of the UATEC held on 16.05.2019 was circulated and one observation was received from Dr. Anil Kumar Singh Jha, Head, Department of Sociological Studies. He informed that Department of Sociological Studies has already taken into consideration the expenditure towards the field tour for MA Social Work programme which is an integral part of the course and an amount of Rs 5000/- is charged from the students of MA Social work on account of field tour. The UATEC advised the Head of Department to take steps in the same line for their respective programmes and also to develop programme specific guideline for field tour comprising all aspects including the frequency of the tour as decided in the last meeting.

To discuss and approve the cut off criteria / marks for admission in Integrated UG, PG and Ph.D. programmes.

Resolution No. 02/UATEC-18/19

The subject wise result of CUCET – 2019 was placed before all HoDs for deciding the category wise cut off marks with respect to the numbers of students to be called for admission (against the vacant seats as per the notified schedule to be held from 28/06/2019 to 04/07/2019 (UG/PG programmes) and on 15.07.2019 to 16.07.2019 (for Ph.D. programmes).

It was also resolved that the cut off marks for PWD candidates in each subject will be the same as fixed for SC/ST category for the respective subject.

For Ph.D. program the UATEC further resolved that based on the UGC (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2016 and its amendment dated 27.08.2018, all such students who have qualified the CUCET entrance test with 50% and above marks will be called for interview/viva – voce on 15th and 16th July, 2019. However the relaxation of 5% marks (from 50% to 45%) shall be allowed for the candidates belonging to SC/ST/OBC (Non Creamy layers/Differently-abled category. Also the NET-JRF/NET-LS/GATE/SLET candidates who are exempted from CUCET are to be called directly for interview / viva – voce. In view of the large number of students qualifying for Ph.D. admission, it was decided that the schedule of dates be revised as follows for Ph.D. admission so that in case large number of students report the interviews can be carried over to the next day.

- (i) The minutes of the 18th AC held on 05.02.2019 was considered and approved.
- (ii) The EC considered and approved the exemption of Hostel fee and Tuition fee in case of Ranjeet Kumar (CUSB1811124032) and Arun Kumar (CUSB1811124005) both belonging to SC category (Mushar) and students of BA B.Ed. integrated programme. The EC resolved to grant waiver of Hostel fee and Tuition fee for the Academic Session 2019 – 2020 to both the students.
- (iii) With respect to the issue of teaching of UG courses under department of Education and Law by the faculty of various departments the EC approved the teaching of integrated courses of any department by the teacher of concerned department (s) extending full cooperation and that no teacher can refuse to teach courses of his / her area / specialization so long as the teaching load is as per UGC norms.


Resolution No. 5/UATEC-18/19
